December 5, 2017

Council for the City of Crittenden met for its regular meeting with the following present:

Mayor James C. Livingood; Councilperson Jim Purcell; Councilperson Earlene Stumbo; Councilperson Donna Duley; Councilperson Roger Humphrey; Councilperson Clara Brown; Councilperson Brian Barkley; Fire Chief Lee Burton. Guest: Stephanie Huhn; Kristen Brugger; Jennifer Williams.

Mayor Livingood called the meeting to order at 7:00 p.m.

Agenda was approved.

Motion by Councilperson Clara Brown, seconded by Councilperson Brian Barkley to approve the minutes of the regular meeting, November 7, 2017. Motion carried, all yes.

Motion by Councilperson Jim Purcell, seconded by Councilperson Roger Humphrey to approve the treasurer's report for the month of November 2017 as read. Motion carried, all yes.

Jennifer Williams updated council on the progress of the city website.

Mayor Livingood updated council regarding the County, AMR Ambulance Service and the City of Dry Ridge Ambulance Service.

Stephanie Huhn and Kristen Brugger with Bramel & Ackley presented the audit report to the Mayor and council.

Council heard the 1st reading of Ordinance No. 188-2005 an ordinance amending the joint ordinance of the County of Grant and of the Cities of Crittenden, Corinth, Dry Ridge and Williamstown, Kentucky.

Council heard the 1st reading of Interlocal Cooperation Agreement originally; made and entered into on the 23rd day of August, 2005 pursuant to the Kentucky Interlocal Cooperation Act, KRS 65.210 et seq., by and between the Kentucky State Police and the County of Grant, and the Cities of Crittenden, Corinth, Dry Ridge and Williamstown, for the establishment of Public Safety Answering Points (PSAPS) to answer all Enhanced 911 calls originating from the County and Cities that are parties hereto through the Enhanced 911 Emergency Service System (E911) which is to be established, and subsequently amended and entered into by the above parties on this the 6th day of December, 2017 a joint ordinance of the County of Grant and the Cities of Crittenden, Corinth, Dry Ridge, and Williamstown, Kentucky amending the original ordinance.

Mayor Livingood informed council that there would be a special meeting called for Wednesday, December 06, 2017 @ 7 p.m. to have the 2nd reading of Ordinance No. 188-2005 and Interlocal Cooperation Agreement.

Motion by Councilperson Clara Brown, seconded by Councilperson Brian Barkley to adjourn to next regular meeting January 2, 2018. Motion carried, all yes.
