Councilperson Todd Roberts asked to add Oakwood Drive Project to old business and under new business add possible new businesses coming to Crittenden to the agenda. Councilperson Paula Lowery asked to add Grant County Sheriff's Department to the agenda.

Councilperson Todd Roberts asked how the Oakwood Drive Project was coming along and did the city get the easements for the project. Mayor informed council the city was able to get the easement. The city is hoping the project will get started in February.

Mayor Patton suggested the city hire Fred Spanier as volunteer so he would be covered under the city's liability insurance because Fred is helping with IT. One citizen suggested hiring Fred Spanier for \$1.00 per year so he would be an employee. Council suggested to ask Alex his opinion on this matter.

Motion by Councilperson Todd Roberts and seconded by Councilperson Danny Martin to table the hiring of Fred Spanier to next month. Councilperson Todd Roberts asked if the city had any information about any businesses coming to the location across from the Whippy Dip on South Main Street. City only had some inquiries on the zoning for the property.

Mayor Patton informed council that Ryan with Cincinnati Bell would be at the council meeting on February 4th 2020 to discuss fiber optics in the city limits of Crittenden.

Councilperson Paula Lowery wanted to talk about the Grant County Sheriff Department compared to having a city police department. Discussion was held by council members, citizens and Grant County Sheriff Chief Deputy Todd Cummins.

Mayor Patton informed council and citizen of a meeting she attended on January 6, 2020 with Duke Energy. Duke Energy announced they are going to increase rates by 16%. The last time Duke Energy raised rates was 2 years ago and raised them by 16%. Mayor Patton encouraged everyone to write letters to their state representative, state senator and the Kentucky Public Service Commission.

Crittenden Fire Chief Lee Burton gave a monthly report to the Mayor and Council.
