July 2, 2019

Council for the City of Crittenden met for its regular meeting with the following present:

Mayor Patton called the meeting to order at 7:00 p.m.

Motion by Councilperson Jennifer Thurman-Humphrey, seconded by Paula Lowery to approve the agenda with the following additions: 1st reading of ordinance regarding the repeal of the ABC ordinance per Councilperson Lowery’s request, 1st reading of ordinance regarding cost of copies per Councilperson Humphrey’s request, and 1st reading of ordinance regarding the procurement policy per Councilperson Humphrey’s request. Mayor Patton read Resolution 253-2019 regarding the Law Enforcement Agreement with the Grant County Sheriff Department.

Council received an updated EMS Agreement.

Mayor Patton and City Attorney Alex Edmondson spoke on the importance of the 2020 US Census and how it can impact the city in a positive way.

Discussion regarding the cleaning of the city building. Councilperson Danny Martin wanted to see inmates used to clean the city building. Donna Duley spoke up against the use of inmates to clean the office. Councilperson Danny Martin suggest that JD Dezarn cleans the office during the day as part of his work week. Councilperson Danny Martin suggested to the Mayor to receive some bids for cleaning the office. Mayor Patton suggested that this issue be tabled to the August council meeting.

Code Enforcement Officer Wanda Hammons presented a Mayor and Council with a monthly report.

Grant County Sheriff Deputy Todd Cummins gave a monthly report, which will be emailed to the Mayor and Council.

Crittenden Fire Chief Lee Burton handed out a monthly report to the Mayor and Council.

Council heard the 1st reading of the ordinance regarding copies presented by Councilperson Humphrey.

Council heard the 1st reading of the ordinance regarding the repeal of the ABC ordinance presented by Councilperson Lowery.

Council heard the 1st reading of the ordinance regarding the procurement policy presented by Councilperson Dusing.

Motion by Councilperson Paula Lowery, seconded by Councilperson Jennifer Thurman-Humphrey to allow the payment of \$20,808.22 to be payable to the Kentucky League of Cities to pay the worker compensation, property and liability insurance.
