Treasurers Report - November 2020 to be approved.

- Summary provide Clerk / Treasurer McHolland
  - Lowery: Beautification budget was only \$500. I felt the budget was set at \$3,500.
    - Humphrey: The budget was cut to allow for additional EMS monies needed for FY20-21.
- Advertising budget needs to be amended line item is over budget
  - McHolland reported the amount of publications in the Grant County News is the reason for added expenses. This line needs to be amended.
- McHolland explained the matured CD movement to the Money Market Fund at Forcht Bank. The CD rates are very low .30% as quoted by Forcht Bank. The Platinum Money Market Fund was quoted at .65% APR. The move was approved by Mayor Purcell. The MM Fund allows the City of Crittenden the flexibility to cover the monies back into a CD when the rates return to better levels.
- Street sign monies allocated in the budget was split between the three line items evenly. The signs purchased cover additional signage needed elsewhere in the city. This budget amendment will be reallocated to Street Maintenance budget line item.
