7. Harvesters Land Proposal – Purcell

- a. Track of land on Violet Road in front of the Harvesters Sub-division
 - i. Map # 042-00-00-024.01
- b. The land has been offered to the City of Crittenden by the current (Hicks & Mann) owners.
- c. The offer is time limited / sensitive.
- d. Councilperson Humphrey:
 - I am concerned about the property. Including run off into the lake and the condition of the dam. The City of Crittenden does have an obligation to the residents of the Harvesters Subdivision to ensure they have a safe entrance and exit of the area.

e. Purcell:

i. We are obligated to the residents.

f. Newman:

i. I agree with Mayor Purcell, we are obligated to the residents of the Harvesters.

g. Dusing:

- i. In the past, we have been told the condition of the dam is poor. We saw a score of 2 out of 5. 1 equaling poor and 5 equaling excellent in regards to the condition of the dam.
- h. Logan Murphy (City Engineer Hicks & Mann):
 - i. From memory, the State classified the damn as an A or B type of dam, but it was designed as a C classification.
 - ii. As-builts were sent to the State of Kentucky in 1994.
 - iii. The hydraulic design differences between an "A" and a "C" is significant. This is causing concern & confusion over the dam.
 - iv. Ongoing maintenance will be necessary by the City of Crittenden
 - v. Sewer is the responsibility of the Grant County Sanitary & Sewer.

i. Purcell:

i. The open law suit from the property owner is to defend themselves against owning the maintenance of the dam.

i. McHolland:

- i. Is there a cost estimate available on "fixing" the dam and maintaining the property?
- ii. Murphy:
 - 1. Fixing the dam will include clearing brush evaluating the seepage. I do not have an estimate available to share.
- k. Motion by Councilperson Newman: The City of Crittenden will accept the property donation.
- I. Second: Bohman

m. Discussion:

- Dusing: The second means of egress from the Harvesters is less critical if the dam is properly maintained / report. Then the city could market and sell the land to a developer.
- ii. Newman: If the damn broke then FEMA would support.
- iii. Murphy: Another option is to drain the lake. The lake is designed to be a dry retainage pond.
- iv. Dusing: The proposal needs to be acted upon as soon as possible.
- v. Bohman: Fishing in the lake has been an issue by the residents that do not own property adjacent to the lake. Potential positive use for the residents.

 - i. Case 25 LLC: A1 to I1
 - ii. Zoning & Marketing Agreement of properties along N Main St & Violet Rd.
 - 1. All property owners are on board CLC Diversified / Beach & Colson
 - 2. Worthington Family did not sign up.
 - b. Case 25 LLC is very eager to move the zoning to I-1.
 - c. Both projects are moving forward City Attorney Brandon Voelker will take both to Planning & Zoning.
- 2. Bid Package Release Oakwood Drive Project Purcell
 - a. Murphy notified the Council of a couple of contractual changes:
 - i. The bidders must submit a schedule to allow the city to understand the project duration start to finish.
 - ii. Estimate: Will include additional details in the bid.
 - iii. Retainage will be added to the contract. Meaning the project owner (City of Crittenden) will hold back a fixed percentage (3, 5 or 10%) of the overall project cost. This retainage will hold the bidder to complete the project and any punch list items discovered by the engineer. Once the project is 100% complete, the retainage payment will be released.
