Discussion:

- Bohman: Oakwood Drive Project What is our path going forward for budget purposes?
 - Purcell: We will keep the current Oakwood allocation for budget purposes. The current budget is set at \$275,000.
 - Bohman: Agree.
- 2. Winter Season Planning: Salt storage Purcell
 - a. Purcell: Salt Building located behind the Firehouse.
 - i. I would like to re-visit that use. One potential bidder for the Snow / De-ice RFP recommended we store salt in house for back up.
 - ii. RFP will be provided to Council for review.
 - b. Humphrey: It is a shame we did not know of a need when we gave approval to the firehouse.
 - c. Dusing: We need to keep in mind the salt bldg. is an old bldg. We should review the structure to see if added structural support is needed.
 - d. Council agreed, we need to ensure the city is covered during the winter season. If storage of salt helps ensure good road coverage we should move forward with preparation.
 - e. Purcell: I will notify Chief Burton to this potential need.
- 3. Humphrey: I would like to discuss the current Noise Ordinance for the City of Crittenden.

- a. Purcell We should pull the Ordinance for review.
- b. Humphrey Please add this topic to our agenda for the May 10th meeting.

Order of Old Business:

- 1. Oakwood Drive Project Bid
 - a. Logan Murphy City Engineer with Hicks and Mann:
 - i. I gave an estimate back in Sept 2021 for budgeting purposes. The market value of this project at that time was roughly \$275,000.
 - ii. Both proposals are certainly high and I recommend rejecting both bids. Market demand and material costs drove the significant increase in costs.
 - iii. I am disappointed to see no local bidders submitted a bid.
 - iv. There is a large disparity within the numbers between both bids.
 - v. Materials costs are more than double normal cost levels.
 - b. Tanner:
 - i. Can we push the bids back and ask the bidders to sharpen their pencils?
 - ii. Purcell: We should reject both bids under KRS Chapter # 45a and authorize the city to competitive negotiation and / or re-bid the project.
 - iii. Discussion:
 - 1. Dusing: Did we have a pre-bid?
 - 2. Murphy: We did not hold a pre-bid mtg.
 - 3. Humphrey: I really want this project to take place right away how long will the negotiation take to get done before we pre-bid?
 - a. Purcell: This will not take long.

- 5. AirBnB Decision Purcell
 - a. Purcell: The Text Amendment has not been filed. Do you want to continue with this change?
 - b. Humphrey: I have had second thoughts about this situation. I would like to look at the language of the change.
 - c. Livingood: I need to look at the details to see what the implications are to changing it. Can we table it to the next meeting?

- 6. Sidewalk / Street Mowing Purcell
 - a. Resident asked Mayor Purcell: Why is the city mowing the strip of grass between the street and sidewalk?
 - b. Humphrey: We have been doing this for a while now in other areas in the city.
 - c. Bohman: Are we not expanding the sidewalks in the near future?
 - i. Purcell: Yes, but this project will take some time.
 - d. Tanner: I want to keep the sidewalks looking good.
 - e. Dusing: I agree with Mr. Tanner cut / edged / blown off.
 - f. Bohman: This is not an added cost since we have a full-time maintenance person doing the work.
 - g. Humphrey: We should go to a part time maintenance person. When the mowing scope shrinks, this may help this complement the situation.
- 7. Zoning Update Dusing
 - a. The Planning & Zoning meeting for 4/25 was cancelled and move to May 12th. The zoning change request for Case 25 LLC and Violet / Main St zoning change will be heard on May 12th at 7pm.
 - b. Barrett Paving: Non-conforming property use within the Case 25 LLC area.
 - i. Purcell: I will research and discuss this situation with Councilperson Dusing.
