- 1. Law Enforcement Report Deputy Sherriff Cummins
 - a. The Sherriff's Department: 3rd shift has been in the city quite a bit this month. Focused on the side streets.
 - b. Dusing:
 - i. In reference to the body that was found in the wildlife refuge, was the GC Sherriff's Dept involved?
 - ii. KSP discovered / investigated the issue. GC Sheriff offered their help, but KSP took the investigation.
 - c. Roberts:
 - i. Large drop in traffic stops is this correct?
 - ii. Sherriff Cummins: It does seem very low at 10. I will check the report and let you know.
 - d. Martin:
 - i. Can the Sheriff's dept break out the citations for the City of Crittenden vs the total in Grant County?
 - ii. Sheriff Cummins, I will make the request for the City of Crittenden.
- 2. Fire Department Report (Report provided) Chief Burton
 - a. One truck is down for maintenance (preventative only).
 - b. No major concerns at this time.
 - c. Roberts: Doe the Firehouse have any building repairs needed at this point in time?
 - i. Chief Burton:
 - 1. Concrete / Drain Issue inside the firehouse.

- 2. I will collect the information and provide it to City Council.
- 3. Economic Development Jamie Baker
 - a. 208 Property Prime piece of real estate in Grant County if the City of Crittenden can assemble the surrounding property owners.
 - i. City of Crittenden has a golden opportunity within this current market.
 - ii. Bill Dennison and Logan Murphy are on the board and are in attendance.
 - iii. What is the long term goals for the City of Crittenden?
 - b. Economic Development:
 - i. Master Planning
 - ii. Overall Zoning Plan
 - c. Comprehensive Plan
 - i. Must be updated
 - ii. Judge Dills is receiving the requests from my office all of the time.
 - d. Planning Commission: Nancy Duley is not going to run again open position for the City of Crittenden.
 - e. Dusing:
 - i. Has Fiscal Court reached out to the firm in Georgetown, KY that provides a team that can construct a Comprehensive Plan for the county?
 - 1. Baker: I am not aware of the communication if it has taken place.
 - 2. Dusing: This is very disappointing; the firm would have provided the county and the cities are strong foundation to work from.
 - f. September Meeting is on the schedule for the Fiscal Court– Same Day as the 9/11 meeting.
 - i. Jim Purcell to talk to Judge Dills about the meeting time / place?
 - g. One example of coordination / planning from a cities perspective is the Conrad Road Project in Williamstown. Property owners and the city is working on a great project for the city.
 - h. IDA owned property on Miller Drive 2.2ac
 - i. Property is being marketed along w/ a larger mass of land on the north end of Crittenden / Grant & Kenton county.
 - i. Travel:
 - i. 93% occupancy rate in the Grant County hotels / Airbnb's is extremely positive.
 - ii. Hotels in NKY are holding an 84% occupancy rate.
 - j. September 18th Harvest Festival?
 - i. Will Crittenden continue to do this festival?
 - 1. Humphrey / Dusing / Bohman / Tanner No
 - 2. The event will be postponed until 2022 per City Council.
 - ii. September 17th will have a live band at the GC Park. 6:30 9:30 no charges to vendors.
 - iii. City of Dry Ridge is postponing the Fall events due to Covid fears.
 - k. Infrastructure Issues in the City of Crittenden: Jamie Baker
 - i. Water is an issue example: a potential industrial company is needing 2 million gallons per day for their operation. Bullock Pen / Grant County cannot handle this demand.
 - ii. Logan Murphy:
 - 1. Zoning issues have been a big issue.
 - 2. The City of Crittenden must gather property owners at the intersection of Violet Rd / US 25 to offer the properties as one parcel to attracted companies.

- a. The entire are should be Highway Commercial.
- b. Then the City of Crittenden can stipulate certain types of businesses only
 - large grocery, commercial bldgs. / offices and so on.
- I. Dusing:
 - i. No one has talked to the other owners.
 - ii. What is your experience of bringing multiple owners together?
 - 1. Logan Murphy said it will take the City of Crittenden to take control and make the meetings take place.
 - iii. Zoning issues for the City must be resolved now before it is too late.

m. Dusing:

 - 1. Re-zone our current properties now
 - 2. I am not confident we will ever see a new Comprehensive Plan.
 - a. We need to use the Georgetown Consultant American Planning Associates.
 - 3. Baker: Judge Dills is willing to spend some monies to produce the Comprehensive Plan.
- ii. Dusing: 208 / Violet Rd / Industrial Complex (North) is our areas of focus. We need to move forward for the city and not wait for the county.
- iii. Dusing: Some good feedback from residents in Grant County Heritage Day was a great event.

 - i. Harvestors is missing nearly all of their street signs
 - ii. We need to order street signs with $12' \log post 10'$ above ground.
 - iii. Council / Mayor have agreed to start at the Harvesters.
 - 1. Mayor Purcell will coordinate with JD Dezarn.

 - i. Mayor Purcell will work w/ Mandy on this report for the September 14th City Council meeting.
