### Order of New Business:

- 1. Ordinance No. 297-2021: 2021 Property Tax Rate 1<sup>st</sup> Reading
  - a. 1<sup>st</sup> Reading was conducted by Mayor Purcell
    - i. Second reading will take place during the next City Council meeting on 9/14/2021.
- 2. Post Office Basement Purcell
  - a. Mayor Purcell provided some background to the situation.
    - i. Commonwealth of Kentucky (Frankfort) called to inquirer about any city owned property that may be available for lease.
    - ii. Clerk McHolland coordinated w/ Frankfort & Mayor Purcell for a walkthrough meeting at the 101 S Main Street Current Post Office basement.
    - iii. The representatives from Frankfort liked the location (Northern section of Grant) and located on Main Street new 175. Plus, the available space was plenty of area.
    - iv. The representatives mentioned that a few improvements would be needed. Mayor Purcell will contact a local contractor for an estimate.
    - v. Frankfort representatives will follow up with the City of Crittenden on their decision.
  - b. Mayor Purcell asked for an estimate from a local contractor to under what we are looking at.
- 3. LED Upgrade City Bldg / Firehouse McHolland
  - a. Motion: Bohman
  - b. Second: Dusing
  - c. Discussion:
    - i. The LED upgrades proposed:
      - 1. City Bldg. (117 S Main Street): Interior bulbs only qty of 43
      - 2. Firehouse (104 S Main Street): Exterior bldg. lights only qty of 6
      - 3. Duke reports were provided for both location by McHolland
      - 4. ROI was provided for each location as well.
    - ii. Martin:
      - 1. Can we keep the old bulbs?
        - a. McHolland: We cannot keep bulbs. Duke will be required to recycle the bubs.

- iii. Mayor Purcell:
  - 1. Does Council approve this improvement?
  - 2. All 6 Council Members approved the project for both locations
