- 1. ORDINANCE NO. 289-2021: Ambulance Service District Ordinance 2nd Reading
 - a. 2nd Reading completed by Mayor Purcell
 - b. Discussion:
 - i. Dusing: I felt we were holding to see the Dry Ridge EMS presentation and the current situation. So, the council can research the situation.
 - 1. Purcell: This ordinance creates a board of directors for the City of Crittenden and to create the best situation from an EMS perspective for the City of Crittenden.
 - ii. Humphrey: Would the city of Crittenden be double taxed County and City?
 - 1. Purcell: I believe the max tax rate cannot be exceeded by one or more taxing districts, but I have not researched this situation to be 100% confident.
 - iii. Roberts: How is the board created and who would be on the board?
 - 1. Purcell: I believe it is a 3-person board for a city under 50,000 residents and appointed by the Mayor. No terms are generated.

- iv. Humphrey: I really just need to understand my we are in this situation from a financial perspective.
- v. Martin: Quoted Paula Lowery, receiving information on the exact runs and are the runs in Crittenden city limits? Or just an area north of Dry Ridge?
- vi. Dusing: Qty of runs in 2018 & 2019 were nearly equal and the costs would be shared equally in regards to volume. I just surprised by the double / triple our costs.
- vii. Purcell: We must have the tax request to GC PVA by the first week in April, 2020.
- viii. Bohman: What amount of money can we expect to see what will come in from tax revenue?
 - 1. Purcell: The ordinance includes \$.05 for every \$100 in assessment value.
- ix. Bohman: We want to ensure the residents are covered by an EMS provider from some entity.
- x. Roberts: If it costs you an additional \$100 per year, you want the right people / right equipment to be there for you in the emergency! I believe we are paying for runs outside the district.
- xi. Purcell: Everyone is the 911 organization EMS works together and backs each other up.
- xii. McHolland: Audit the books to understand a clear picture of the costs and the current situation.
- xiii. Roberts: The county is costing \$1.2 million
- xiv. Purcell: I believe the issue is a county issue, but that option is not available today.
- xv. Guest (Jim Morris):
 - 1. Looking at overall taxes, where is my money going to?
 - 2. Small city growing pains, I completely understand where the city is in its current situation.
 - 3. The county needs to hold the EMS taxing district.
 - 4. Concerned with Rural Metro / AMR, really no regulations to control the costs and how they are billed.
 - 5. Charge by runs so we have transparency.
 - 6. The national companies are going to bill as they want to bill. The city cannot contain the costs.
- xvi. Martin: Wants Dry Ridge to have the numbers ready by 2/9/2021.

 - b. McHolland: Announced 2 bids:
 - i. Catlett Construction: \$950.00
 - ii. Pro Innovations: \$1120.00
 - c. Roberts: Fecon eats up the small trees.
 - d. Roberts: I believe we should reject the bid too expensive.
 - e. Martin: Since we did not do the entire property the first time, the back end of the property was not done and we have the current mess to deal with.
 - f. Can we have our maintenance team mow the area?
 - g. Purcell: I will ask to see what is our options?
 - h. Roberts: Can we call Arts Rental for the equipment?
 - i. Purcell: Can we have someone call Arts?
 - j. Humphrey: Will check with the county to see if we can hire them or borrow the equipment?

- d. Humphrey: Were the timesheets submitted in previously for approval?
- e. Martin: Personal policy: the clerk should have the timesheets.
- f. Purcell: I brought this to your attention for your purpose, the city may be liable to pay this amount of money plus penalty.
- g. Martin / Humphrey: Wants a signed document from Dezarn stating the hours and why it was not paid.
- h. Bohman: wants to know why he spent 6 hours at the hearing?
- i. Roberts: how do you know he spent 3 hours of OT back in Feb 2020?
- j. Martin: documentation must be presented by Dezarn.
- k. Purcell: Dezarn: to write a statement asking who made him work OT w/o compensation. Martin wants timesheets to understand the hours.
- I. Humphrey: I do not have an issue with Mr. McHolland's hours since he was on probation and required to attend / participate in each meeting.
