  - a. Resolution was read by Councilperson Purcell.
  - b. Open discussion occurred:
    - i. Edmondson: Questioned the public hearing timing. The resolution stated the public hearing would take place on November 19<sup>th</sup>, 2020 @ 8pm. 2 days' notice for the hearing is not reasonable. He is concerned the city may be sued by the defendant.
    - ii. Voelker: Explained that a City Councilperson has received threats over the matter. No rule in timing is provided. No public intervention
    - iii. Edmondson: Asked is this enough time?
    - iv. Voelker: Should the Mayor ask for more time? There is no hidden agenda behind the resolution.
    - v. Mayor Patton: I would like to have at least one week to ensure an attorney can be available. I would like to set the hearing date at Monday, November 30<sup>th</sup>, 2020 @ 7pm.

- vi. Edmondson: We should allow the AG to make the decision. I am concerned that the city could be sued over timing.
