 - a. Purcell:
 - i. The city has received a request from a resident on Eagle Creek Drive to install street speed humps like the street speed humps in the Harvestor's Subdivision.
 - ii. The request came from Dennis Mann. Vehicles speeding on the street is his concern.This a safety concern for the residents including the kids living on the street.
 - iii. The city could include this work into a future street rehab project if Council wants to proceed.
 - b. Purcell: Should I ask our Civil Engineer to research the locations and quantity that would benefit the residents?
 - c. Livingood: Should we reach out to the residents on Eagle Creek and gather more input?
 - i. Purcell: It would be good to bring the concern to everyone's attention.
 - d. Purcell: We can table the concept until a future meeting if Council would prefer to do some further research.
 - i. Saylor: We can just wait until additional complaints come to the city.
 - e. Purcell: This topic will be tabled to a future meeting if necessary.
- 2. Resolution Walters-Sydnor Properties R3 to HC Zoning Change Purcell
 - a. The Resolution was introduced by Mayor Purcell.

 - a. Street Rehab Project is complete!
 - i. Ridgeway / Turner / Bingham / Claiborne has been resurfaced by Riegler Blacktop
 - ii. Mayor Purcell: Very good project. I believe Riegler Blacktop did a very good job!
 - iii. Tanner: Bingham had one issue with the transition of a driveway at 298 Bingham Lane. Mayor Purcell will follow up Hicks & Mann on the issue.

- b. Oakwood Drive Project:
 - i. Purcell: The construction / utility work started during the week of August 14th, 2023.
 - ii. Tanner: The Oakwood Drive Project is progressing well in my opinion.
 - iii. Dusing: Any concerns from the public as of yet?
 - 1. Purcell: No major issues as of yet. The only complaint was from the 1st house (225 Oakwood Drive Owner: Bobbie Barton) on the right. The city has an easement through the yard between the two houses (225 and 235 Oakwood Drive).
 - a. The construction / drainage plan would have run through the yard requiring a tree to be removed. The owner wants to keep the tree, the construction plan has been revised by Hicks & Mann and Riegler Blacktop.
 - b. A drainage pipe under the road will be cleaned out / replaced to allow water to the flow onto 225 Oakwood Drive property. The property owner accepted this solution.
 - iv. Purcell / McHolland: Change Order process should be followed by Hicks & Mann and Riegler Blacktop. Mayor Purcell will follow up with Hicks & Mann tomorrow (8/23).

• Bohman:

- I have concerns with the Personal / Tangible Tax rate of .500 for every \$100 of assessment value for 2023.
- o I believe this will hurt small businesses and the residents with their personal property tax bills.
- We should stay with rate that was utilized in 2022.

McHolland:

- The rate preparation process was correctly followed.
- o The certified Real and Personal Property Assessments were delivered by Grant County PVA.
- o The Personal / Tangible Property Assessment total dropped.

2022: \$18,792,634

2023: \$5,833,089

- The information was delivered to NKADD to assist the City with calculating the 2023 Property Tax Rates Real and Personal.
- With the large decrease in assessment value, the compensating rate calculation provides the tax rate that will match the revenue level of 2022.

Purcell:

- o The tax rate preparation process was correctly followed.
- The process is set in place to ensure Cities can meet their financial obligations set for the fiscal year.
