- 1. Law Enforcement Report
 - a. Report was not provided by the Sheriff's Dept. prior to the meeting. We assume they are having the same software issue.
 - b. No discussion
- 2. Fire Department Report
 - a. Report was not provided by the Fire Dept. prior to the meeting.
 - b. Software issue communication error.
 - c. Burton:
 - i. We are approaching the burn ban: Oct 15 Dec 1 no burning during the day (06:00 to 18:00 hrs). State wide burn ban.
 - ii. You can burn between 18:00 hrs and 06:00 hrs.
 - iii. Local dispatch must be notified: 859.428.1212
 - iv. You must be in person / present for the entire burning session.
 - v. You must have a way to put out the fire water supply / sand.
 - vi. You cannot burn tires, rubber synthetic materials, nothing painted or treated standard restrictions.

- 3. Crittenden Ambulance Tax District Report
 - a. Monthly report was provided (Monday 10/9) prior to the meeting.
 - b. Burton: Monday (10/16) monthly meeting must be cancelled and postponed to November. This is due to schedule conflicts for the Board Members.
- 4. Ordinance No. 322-2023: Parking Schedules 2nd Reading Purcell
 - a. Second Reading was performed by Mayor Purcell.

Discussion:

- Purcell: The topic of street parking goes to back to 1960 original Ordinance.
 - o Current Ordinance prohibits parking on the street. Existing law.
 - The question is, do you want to retain what we have or make the appropriate correction?
- New vs Old difference The new ordinance (322-2023) is removing designated areas.
- 5. Storm Drain Repair Project Purcell
 - a. Estimates to repair storm drains were provided to Council prior to the meeting.
 - b. Council has approved the work, but would like a lump sum cost from the contractor.
 - c. Mayor Purcell will discuss with Eric Walters Services on a lump sum cost.
- 6. Resolution Adopting & Approving Municipal Road Aid Co-op Purcell
 - a. Resolution was read by Mayor Purcell.
 - b. Council voted / signed the Resolution.
 - c. Motion to approve: Bohman
 - d. Seconded: Dusing
 - e. All 6 Council Members agreed with the Resolution Signatures were received. Need to get Greg Ilvingood's signature once he returns to town.
- 7. Crittenden Nature Park Lake Maintenance Proposal Purcell
 - a. Estimate to clean up around the lakefront was provided to Council prior to the meeting.
 - b. Mayor Purcell explained the background.
 - c. Dusing is concerned with altering the dam area of the lake without more data.
 - i. I am strongly against the Waller Rd side / Dam side. I am ok with Violet Road side.
 - d. Livingood I agree with Joe's concern.
 - e. Mayor Purcell lets table the topic to the next meeting. We will reach out to the city engineer for additional feedback.
 - i. The goal of this clean up to improve the fishing situation for our residents.
- 8. 208 N Main Property (Old Trailer Park Area) Tree/Debris Removal Proposal Purcell
 - a. Estimate was provided to Council prior to the meeting.
 - b. Mayor Purcell reviewed the bid proposal from Pro Innovations.

- c. Saylor we should look to match what was done on the corner of Violet Rd and N Main Street (US25).
 - i. Have them rebid it to clean it out and not just grind it down. Better long-term solution
 - ii. Mayor Purcell will go back for a 2nd bid to remove the debris.
- 9. ORDINANCE NO. 323-2023 Zoning Change R3 to HC 1st Reading:
 - a. 1st Reading was conducted by Mayor Purcell.

- 1. Street Project Updates Purcell
 - a. Oakwood Drive is nearly complete!
 - b. Riegler follow up / fixing of open issues Bingham (Barry Kinman) and Ridgeway (Jerry Stephenson).
 - i. Mayor Purcell will follow up w/ Riegler and our city Engineer.
- 2. Crittenden Nature Park Project Updates Purcell
 - a. Contract has been signed.
 - b. Construction will begin this week (week of 10/9).
 - c. Electrical conduit will be added and run to the dock for future use at the request of City Council.
 - d. Future Phase 2: Landscape design meeting will be set in the next couple of weeks.
 - e. Chief Burton suggestion: This would be a great location and good timing to install a dry Hydrant for area.
- 3. Duke Energy LED Lighting Project Updates Purcell
 - a. Project is complete!
 - b. City Council Feedback:
 - i. Ask Owen Electric about LED Street Lights
 - ii. Ask Duke about decorative street lights.
 - iii. Clerk McHolland will follow up on both requests.
- 4. Zoning Case Lane
 - a. Saylor: Aug 8th, 2023 meeting site plan meeting took place between Airport Towing and Grant County Planning & Zoning.
 - b. Saylor: I have talked to Judge Executive Dills / City officials including Mayor Purcell about the open issues / remaining action items:
 - i. Lighting issues
 - 1. No light glare shall be on any property per Council Member Leo Saylor.
 - ii. Trees have not been installed per the site plan.
 - c. Saylor: We need help from the city. What is the next step? What can we do? This type of situation will happen in the future if we do not correct the process now.
 - d. Purcell:
 - i. The lighting issue is the largest issue at hand.
 - ii. Mayor Purcell to City Council:
 - 1. Do you want this office to hire an electrical firm?
 - a. Dusing: Can we use Duke Energy?
 - b. Purcell: I will call and ask again. Duke has been called in the past.
 - iii. Livingood:
 - 1. Has the house across US25 complained about the same glare issue?

- a. McHolland: In a previous Council Meeting, other residents on Case Lane came to the meeting and complained about the lights as well.
- 2. Purcell: Light issue needs to be reviewed by an expert.
 - a. Bohman: The lights are not the only issue at hand. The trees have not been installed.
 - b. Tanner: Agreed, many issues at hand. Are these county issues to resolve?
 - i. Purcell: Reminder, The City of Crittenden has a joint-city/county agreement. The issue falls on both.
- iv. Dusing Could you contact KLC for advice / direction?
- v. Council direction to Mayor Purcell:
 - 1. Contact KLC for advice / direction....
 - 2. Mayor Purcell: I will also reach out to Robert Yeager KYTC District 6 for advice as well.
