

ORDINANCE NO. 339-2024

AN ORDINANCE AMENDING CHAPTER 63 OF THE CITY OF CRITTENDEN CODE OF ORDINANCES PERTAINING TO ABC LICENSES

WHEREAS, the City of Crittenden has heretofore established an ordinance pertaining to the duration of alcoholic beverage licenses issued by the City of Crittenden; and

WHEREAS, the ordinance pertaining to the duration of alcoholic licenses issued by the City was thereafter codified in chapter 63 of the Code of Ordinances of the City of Crittenden; and

WHEREAS, subsequent legislation has caused the date of issuance and duration of said licenses to have been changed from the initial date of issuance and duration; NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF CRITTENDEN as follows:

SECTION I

Subsection 63.013 (A) (6) of the Code of Ordinances of the City of Crittenden shall be amended as follows:

All licenses approved by the City ABC Administrator or assistant ABC Administrator(s) and issued by the city shall begin on ~~February 1~~ [July 1] of any year and shall expire on ~~January 31~~ [June 30] of the following year.

SECTION II

Subsection 63.013 (A) (8) of the Code of Ordinances of the City of Crittenden shall be amended as follows:

The yearly license term is ~~February 1~~ [July 1] to ~~January 31~~ [June 30]. Any licenses issued after July 1 of any year shall be assessed a fee which is based on the pro-rated portion of the remainder of the license period. However, the cost of any license shall not be less than that for a period of six months.

SECTION III

The provisions of this ordinance are severable and the invalidity of any provision of this ordinance shall not affect the validity of any other provision thereof and such other provisions shall remain in full force and effect as long as they remain valid in the absence of those provisions determined to be invalid.

SECTION IV

This ordinance shall be effective as soon as published according to law.

SECTION V

This Ordinance shall be published in summary pursuant to K.R.S. 83A.060(9).


